

## Terms of use of the documentation system "ICdoc pro"

of the "Österreichisches Zentrum für Dokumentation und Qualitätssicherung in der Intensivmedizin (ASDI)", being valid for all USERS, these are the intensive care units (ICUs) using this program.

1. The "Österreichisches Zentrum für Dokumentation und Qualitätssicherung in der Intensivmedizin (ASDI)" exclusively gives the right to the separately authorized USER for the duration of his ASDI membership and after payment of the annual membership fee to use the program **ICdoc pro** on a single designate Personal Computer System. Transference or duplication of the programs are not allowed (with the exception of a temporary transference in case of a malfunction of the designate system).
2. Object of this agreement is the use of the program **ICdoc pro** for the purpose of quality assurance, medical performance evaluation and cost accounting. It is hereby stated that the program is not intended as a tool for diagnosis and therapy.
3. The use of the submitted software is exclusively restricted to the under point 2. defined purpose and for the documentation of data for scientific interpretation. Every other use is particularly forbidden. Use of the software does in no way replace the legally stipulated patient documentation. For property claims, especially of medical kind, resulting from inappropriate use of the program, there is no assumption of liability by ASDI.
4. Reverse engineering, deassembling or decompiling of the embedded programs are not to be carried out by the USER or any third party.
5. The USER appreciates that **ICdoc pro** is on copyright the protected property of the "Österreichisches Zentrum für Dokumentation und Qualitätssicherung in der Intensivmedizin (ASDI)". Any rights concerning property, copyright and other commercial protective rights on the programs, updates and the documentation belong to the above owner. The same applies to any changes and translation of the programs.
6. Any rights granted to the USER cannot be transferred. Rental, transfer as well as resale of the programs by the USER are excluded. Under violation of these terms the USER is not allowed to duplicate the programs either partially or as a whole by himself or any third party.
7. The USER acknowledges, that the liability of the "Österreichisches Zentrum für Dokumentation und Qualitätssicherung in der Intensivmedizin (ASDI)" for any damages to intentional damage and gross negligence is limited. Agreed, this liability is limited to a maximum amount of liability of 50% of the member charge / the licence fee. The liability for slight negligence is excluded entirely.
8. The use of the software **ICdoc pro** is only permitted to members of the "Österreichisches Zentrum für Dokumentation und Qualitätssicherung in der Intensivmedizin (ASDI)". After termination of membership, the USER is obliged to finish the use of all programs, of the documentations and of all backup copies of the programs and to send a confirmation about the deletion or destruction of the programs within another month to the "Österreichisches Zentrum für Dokumentation und Qualitätssicherung in der Intensivmedizin (ASDI)". The same applies to the documentation.

For technical questions of any kind and maintainance etc. as well as possible elimination of errors and guarantee the company "büll informatik gesmbh" is exclusively responsible. The USER completes an appropriate contract with the company "büll informatik gesmbh" on the maintainance of **ICdoc pro**. Regarding the ORACLE™ software delivered with the data carriers the USER will acquire the required licence and conclude a maintainance contract with the company "büll informatik gesmbh" or a third party.
